Ordinance 310 was adopted by Council Effective 10/29/81.

Section 12-1: Every person (shall include individual, partnership, corporation, or any other entity) who conducts any business or or engages in any trade or occupation from any premises or who use a vehicle for such purposes within the City shall procure a license in the manner prescribed in this article and shall pay the required fee. A license shall be obtained, and the required fee shall be paid for each separate premises maintained by the license.

Section 12-5: A license shall be valid for one calendar year and shall expire on the last day of December.

Section 12-6: THE FACT THAT A LICENSE OR PERMIT HAS BEEN GRANTED TO ANY PERSON BY THE STATE TO ENGAGE IN THE OPERATION, CONDUCT, MAINTENANCE OR MANAGEMENT OF ANY BUSINESS, TRADE, OCCUPATION OR PREMISES SHALL NOT EXEMPT SUCH PERSON FROM THE NECESSITY OF PROCURING A LICENSE FROM THE CITY, HOWEVER, THIS ARTICLE SHALL NOT BE IN INTERPRETED AS GIVING THE CITY ANY AUTHORITY TO REGULATE THE PROFESSIONAL CONDUCT OF STATE LICENSED PROFESSIONAL.

Section 12-7: A penalty of ten (10% percent of any required license fee shall be assessed and paid upon the failure of any licensee to renew such license on or before February fourteenth of any year.

Section 12-10: The license shall carry the license on his person when engaged in business for which the license as granted or conspicuously displayed if a fixed location.
